The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision in this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and finds it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

## **FINDINGS OF FACT**

- 1. Christina Sinkey, D/B/A Christina's Creations, 909 Monroe Avenue, South Milwaukee, WI 53172, is currently unlicensed as a barber and cosmetology establishment in the State of Wisconsin. Christina's Creations has been conducting barbering and cosmetology services without a valid or current establishment license as required by law.
- 2. According to the Department of Regulation and Licensing records, Christina Sinkey, 909 Monroe Avenue, South Milwaukee, WI 53172, owner and sole practitioner of Christina's Creations, is duly licensed in the State of Wisconsin as a barber and cosmetology practitioner (license #8277005 granted on 9/29/97). As the owner and sole practitioner of Christina's Creations, Christina Sinkey was and is, at all times relevant to this action, responsible for compliance with Wisconsin Statute, Chapter 454 and the Wisconsin Administrative Code for Barbering and Cosmetology Chapters BC 2, 3 and 4.
- 3. Respondent, Christina Sinkey, performed barbering and cosmetology services at Christina's Creations salon without a duly licensed manager of record and without a valid or current barbering and cosmetology establishment license.
- 4. During a routine inspection of Christina's Creations salon, the investigator for the State of Wisconsin observed a sanitation violation for failing to store clean equipment separately from dirty equipment as required by law.
- 5. In resolution of this matter, Respondent, Christina Sinkey, consents to the entry of the following Conclusions of Law and Order.

# **CONCLUSIONS OF LAW**

Christina Sinkey, owner/practitioner, D/B/A Christina's Creations, violated Wisconsin Statutes, Chapter 454.04(1)(a) and 454.08(1)(b) and Wisconsin Administrative Code for Barbering and Cosmetology BC 2.045(1), 3.01(1) and 4.02(3a).

### **ORDER**

NOW, THEREFORE, IT IS HEREBY ORDERED that:

1. Christina Sinkey, owner/practitioner D/B/A Christina's Creations, **shall** immediately (by January 30, 2003), provide the Department Monitor with the names of any and all duly licensed barber and cosmetologists providing services at her salon. Respondent **shall CEASE** operation of the business unless and until she has only duly licensed personnel employed to provide barbering and cosmetology services, a duly licensed manager of record is listed with the State of Wisconsin and the salon has a valid and current establishment license.
