The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision in this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and finds it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

## **FINDINGS OF FACT**

- 1. Headliners Barber & Beauty Salon, 4519 W. Center Street, Milwaukee, WI 53210, is duly licensed as a barber and cosmetologist establishment in the State of Wisconsin (establishment license #30017). This license was first granted on August 29, 2001.
- 2. According to the Department of Regulation and Licensing records, Latasha Robinson, 3802 W. Galena, Milwaukee, WI 53208, is the listed owner of Headliners Barber & Beauty Salon and is duly licensed in the State of Wisconsin as a barber and cosmetologist (practitioner license #76617). As owner, Latasha Robinson was and is at all times relevant to this action responsible for compliance with Wisconsin Statute, Chapter 454 and the Wisconsin Administrative Code for Barbering and Cosmetology Chapters BC 2, 3 and 4.
- 3. On exact dates unknown, but at least on February 13, 2002, Anthony Poorman, Terrance Ward, Yolanda Corley and Tawanda Knox were employed at Headliners Barber & Beauty Salon and were providing barbering and cosmetology services to the public. At no time relevant to this action did Anthony Poorman, Terrance Ward, Yolanda Corley or Tawanda Knox hold a valid and current Wisconsin barbering and cosmetology license.
- 4. On February 13, 2002, an inspection of Headliners Barber & Beauty Salon revealed sanitation violations for failure to change disinfectant on a daily basis and failure to maintain the salon in a clean, sanitary and safe condition. The salon failed to post a price list, disinfectant at workstations was cloudy and dirty with hair debris and inspection of razor attachments also revealed hair debris.
- 5. In resolution of this matter, Latasha Robinson consents to the entry of the following Conclusions of Law and Order.

### **CONCLUSIONS OF LAW**

Latasha Robinson, D/B/A Headliners Barber & Beauty Salon, violated Wisconsin Statutes, Chapter 454.04(1)(a), 454.08(1)(b) and 454.08(6) and Wisconsin Administrative Code for Barbering and Cosmetology BC 2.04(1), 2.05(2), 2.006, 2.07(1), 2.07(2), 4.01(1), 4.02(1) and 4.02(3).

### <u>ORDER</u>

NOW, THEREFORE, IT IS HEREBY ORDERED that:

- 1. Latasha Robinson, D/B/A Headliners Barber & Beauty Salon shall immediately provide the Department Monitor with the names of any and all duly licensed barber and cosmetologists providing services at the salon. Respondent shall CEASE operation of the business unless and until she has only duly licensed personnel employed to provide barbering and cosmetology services. Respondent shall provide to the Department the name of a duly licensed manager of the Headliners Barber & Beauty Salon by February 12, 2003.
- 2. Latasha Robinson, D/B/A Headliners Barber & Beauty Salon shall pay to the Department of Regulation and Licensing a forfeiture of FOUR THOUSAND TWO HUNDRED dollars (\$4, 200.00) pursuant to the following payment schedule below.
