The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Barbers Hairstylists For Men and Women Inc., d/b/a Cost Cutters 6573

("Respondent"), is licensed in the State of Wisconsin as a Barbering and Cosmetology Establishment license # 80 29219. This license was first granted to it on 06/30/00. The most recent address on file with the Department of Regulation and Licensing for this establishment is 5318 S 27th St., Milwaukee, WI 53221.

- 2. Barbers Hairstylists For Men and Women Inc., is listed with the Department of Regulation and Licensing as the owner of Cost Cutters 6573. As owner, Barbers Hairstylists For Men and Women Inc., was at all times relevant to this action responsible for compliance with Wis. Stats. chapter 454 and Admin. Code chapters BC 2, BC 3 and BC 4.
- 3. On September 13, 2002, an investigator for the Department of Regulation and Licensing performed an inspection of Cost Cutters 6573. During the inspection the investigator found the following:
 - a. poisonous substances were not stored in a locked cabinet.
 - b. clean contact equipment was not stored separate from dirty contact equipment.
 - c. contact equipment was not being disinfected.

CONCLUSIONS OF LAW

- 1. The Wisconsin Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to sec. 454.15, Wis. Stats.
- 2. The Wisconsin Barbering and Cosmetology Examining Board is authorized to enter into the attached Stipulation pursuant to sec. 227.44(5), Wis. Stats.
- 3. Respondent **Barbers Hairstylists For Men and Women Inc., d/b/a Cost Cutters 6573** has violated:
 - a. Wisconsin Statutes section 454.15(2)(i) and Wisconsin Administrative Code sections BC 3.01(6), BC 4.01(1), BC 4.02 (3) and BC 4.02(3a) by failing to maintain the salon in a clean, sanitary and safe condition.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED, that the attached Stipulation is hereby accepted.

IT IS FURTHER ORDERED, that Respondent Barbers Hairstylists For Men and Women Inc., d/b/a

Cost Cutters 6573 shall pay to the Department of Regulation and Licensing a forfeiture of TWO HUNDRED dollars (\$200.00). Payment shall be submitted within thirty (30) days from the date of this order. Payment shall be made by **certified check or money order**, payable to the Wisconsin Department of Regulation and Licensing and sent to: **Department Monitor**, **Division of Enforcement**, **Department of Regulation and Licensing**, **PO Box 8935**, **Madison**, **WI 53708-8935**.

IT IS FURTHER ORDERED, that in the event **Barbers Hairstylists For Men and Women Inc.**, **d/b/a Cost Cutters 6573** fails to timely submit payment of the forfeiture as set forth above, the Establishment's license of **Barbers Hairstylists For Men and Women Inc.**, **d/b/a Cost Cutters 6573** SHALL BE SUSPENDED, without further notice or hearing, until respondent has complied with the terms of this Order.

IT IS FURTHER ORDERED, that file, 02 BAC 034 be, and hereby is, closed as to respondent **Barbers Hairstylists For Men and Women Inc., d/b/a Cost Cutters 6573**.
