The Wisconsin Board of Nursing received a Stipulation submitted by the parties to the above-captioned matter. The Stipulation, a copy of which is attached hereto, was executed by Susanne D. Meade, L.P.N., personally, and by Michael Berndt, attorney for the Department of Regulation and Licensing, Division of Enforcement. Based upon the Stipulation of the parties, the Wisconsin Board of Nursing makes the following Findings of Fact, Conclusions of Law, and Order.

FINDINGS OF FACT

1. Susanne D. Meade, L.P.N., was born February 6, 1956. Ms. Meade's latest address on file with the Department of Regulation and Licensing is 407 B 3rd Street, Albany, WI 53502.

2. Ms. Meade is licensed to practice in the state of Wisconsin as a licensed practical nurse pursuant to license #32615, which was first granted on August 27, 1994.

3. On January 2, 2002, Ms. Meade was observed removing an area of eschar with a tweezers and scalpel from the ischial area of an 84 year-old female resident with chronic venous stasis ulcers and peripheral vascular disease that was on Coumadin therapy.

4. There was not a physician's order for the removal of the eschar.

5. Ms. Meade stated in her response to the complaint that she removed the eschar, that she was requested to do so by another nurse and that at no time did she endanger the resident.

CONCLUSIONS OF LAW

1. The Board of Nursing has jurisdiction in this matter pursuant to § 441.07 (1), Stats.

2. The Board of Nursing has the authority to resolve this disciplinary proceeding by Stipulation without an evidentiary hearing pursuant to § 227.44 (5), Stats.

3. The conduct described in paragraphs 3 and 4, above, violated Wis. Adm. Code §§ N 7.03(1)(a) and N 7.04(5).

ORDER

NOW, THEREFORE, IT IS ORDERED that the stipulation of the parties is approved.

IT IS FURTHER ORDERED that:

1. Susanne D. Meade, L.P.N. (license # 32615) is hereby REPRIMANDED.

2. Within nine (9) months of the effective date of this Order, Respondent shall submit documentation of successful completion of a one-day scope of practice course for licensed practical nurses and legal boundaries. To be acceptable, the course or training shall be pre-approved by a member or designated agent of the Board of Nursing. Acceptable documentation shall include certification from the sponsoring organization as well as a statement signed by Respondent verifying that she attended the course(s) in its (their) entirety

3. Respondent will pay a forfeiture in the amount of \$100.00 to the Department of Regulation and Licensing, 1400 E. Washington Avenue, P.O. Box 8935, Madison, Wisconsin, 53708-8935 within sixty (60) days of the date of this final Decision and Order.
