The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

#### **FINDINGS OF FACT**

1. **Tia J. May** ("May"), date of birth 04/28/63, is licensed in the State of Wisconsin as a Barbering

or Cosmetology Manager having license # 81 24836. This license was first granted to her on 06/04/92.

- 2. May is listed with the Department of Regulation and Licensing as owner of the Barbering and Cosmetology Establishment, La Mirage Salon, License # 90 24296. The most recent address on file with the Department of Regulation and Licensing for this establishment is 2475 University Ave. Ste. P., Green Bay, WI 54302.
- 3. At all times relevant to this action, May was the owner and was working as manager of record for La Mirage Salon. As owner/manager, May was responsible for the daily operations of the establishment and for ensuring that the establishment was in compliance with Admin. Code chapter BC 2.
- 4. On February 13, 2002, the Department of Regulation and Licensing was notified that the Barbering and Cosmetology Establishment license of La Mirage Salon had expired on July 1, 2001. The Department was also notified that the Barbering or Cosmetology Manager's license of Tia J. May had expired on July 1, 2001 and was not renewed until September 11, 2001. The Barbering and Cosmetology Establishment license of La Mirage Salon was then renewed on February 14, 2002.
- 5. The Department contacted La Mirage Salon and spoke with May. May stated that the Salon had remained open during that the time its license was expired and was providing services to clients. May stated that during the time her manager's license was expired she was not providing services to clients due to injuries she received in a car accident.

#### **CONCLUSIONS OF LAW**

- 1. The Wisconsin Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to sec. 454.15, Wis. Stats.
- 2. The Wisconsin Barbering and Cosmetology Examining Board is authorized to enter into the attached Stipulation pursuant to sec. 227.44(5), Wis. Stats.
  - 3. Respondents **La Mirage Salon & Tia J. May** have violated:
    - a. Wisconsin Statutes sections 454.08(1)(b) and 454.15(2)(i) and Wisconsin Administrative Code section BC 2.04(1) by providing services to clients without a current Cosmetology Establishment license.

### ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED, that the attached Stipulation is hereby accepted.

IT IS FURTHER ORDERED, that Respondents **La Mirage Salon & Tia J. May** shall pay to the Department of Regulation and Licensing a forfeiture of ONE THOUSAND dollars (\$1000.00). Payment shall be submitted within sixty (60) days from the date of this order. Payment shall be made by **certified check or money order**, payable to the Wisconsin Department of Regulation and Licensing and sent to: **Department Monitor**, **Division of Enforcement**, **Department of Regulation and Licensing**, **PO Box 8935**, **Madison**, **WI 53708-8935**.

	IT IS FURTHER ORDERED, that in the event <b>La Mirage Salon &amp; Tia J. May</b> fail to timely submit payment orfeiture as set forth above, the Barber or Cosmetology Manager's license of <b>Tia J. May</b> (#81 24836) <b>BE SUSPENDED,</b> without further notice or hearing, until respondent has complied with the terms of this
