The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision in this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and finds it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Respondent **Arlene Lim** (D.O.B. 08/21/81) is a manicurist licensed in the state of Wisconsin (license #85-4259, granted on 09/06/00). Respondent is also licensed in the state of Wisconsin as an aesthetician (license

86-516, granted on 02/16/01).

- 2. The latest address for Respondent on record with the Department of Regulation and Licensing, (hereafter "Department"), is 7725 Radcliffe Drive # F, Madison, Wisconsin, 53719.
- 3. Respondent was at all times relevant to this action, the manager of Chic Nails, a manicuring establishment located at 725 N. High Point Road, Madison, WI 53717, (license #71-1489, granted on 08/05/99).
- 4. On July 24, 2002, an announced establishment inspection was performed by the Department. The inspection revealed that Respondent was providing aesthetician services at Chic Nails.
- 5. At the time of the inspection, Chic Nails did not have an aesthetics establishment license.
- 6. An aesthetics establishment license was subsequently obtained by Chic Nails on July 25, 2002.

CONCLUSIONS OF LAW

Respondent, Arlene Lim, has violated the following:

1. Wis. Stats. §454.08(1)(b) which provides that no person may practice barbering or cosmetology, aesthetics, electrology or manicuring in an establishment unless the establishment is licensed to provide that practice under sub.(2).

<u>ORDER</u>

NOW, THEREFORE, IT IS HEREBY ORDERED that:

- 1. Arlene Lim is **REPRIMANDED** and shall pay to the Department of Regulation and Licensing a forfeiture of one thousand dollars (\$1,000.00) within 60 days from the effective date of this order.
- 2. Payment shall be made by certified check or money order, payable to:
