The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

#### **FINDINGS OF FACT**

1. **Carrie L. Hogenson** ("Hogenson"), date of birth 05/23/61, is licensed in the State of Wisconsin

as a Barbering or Cosmetology Manager having license # 81 27822. This license was first granted to her on 05/17/99.

- 2. Hogenson is listed with the Department of Regulation and Licensing as owner of the Barbering and Cosmetology Establishment, Carries Place, License # 80 31024. The most recent address on file with the Department of Regulation and Licensing for this establishment is 1310 Bellevue St., Green Bay, WI 54302.
- 3. At all times relevant to this action, Hogenson was the owner and was working as manager of record for Carries Place. As owner/manager, Hogenson was responsible for the daily operations of the establishment and for ensuring that the establishment was in compliance with Admin. Code chapter BC 2.
- 4. On July 19, 2002, investigators with the Department of Regulation and Licensing inspected the Barbering and Cosmetology Establishment Carries Place. During the inspection the investigators found that Carries Place did not have a Barbering and Cosmetology Establishment license. Hogenson indicated that Carries Place had been operating without a license for about 2 years.

#### **CONCLUSIONS OF LAW**

- 1. The Wisconsin Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to sec. 454.15, Wis. Stats.
- 2. The Wisconsin Barbering and Cosmetology Examining Board is authorized to enter into the attached Stipulation pursuant to sec. 227.44(5), Wis. Stats.
  - 3. Respondents Carries Place and Carrie Hogenson have violated:
    - a. Wisconsin Statutes sections 454.08(1)(b) and 454.15(2)(i) and

Wisconsin Administrative Code section BC 2.04(1) by providing services to clients without a current Cosmetology Establishment license.

### ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED, that the attached Stipulation is hereby accepted.

IT IS FURTHER ORDERED, that Respondent **Carrie Hogenson** shall pay to the Department of Regulation and Licensing a forfeiture of ONE THOUSAND dollars (\$1000.00). Payment shall be submitted within sixty (60) days from the date of this order. Payment shall be made by **certified check or money order**, payable to the Wisconsin Department of Regulation and Licensing and sent to: **Department Monitor**, **Division of Enforcement**, **Department of Regulation and Licensing**, **PO Box 8935**, **Madison**, **WI 53708-8935**.

IT IS FURTHER ORDERED, that in the event **Carrie Hogenson** fails to timely submit payment of the forfeiture as set forth above, the Barber or Cosmetology Manager's license of **Carrie Hogenson** (#81 27822) **SHALL BE SUSPENDED**, without further notice or hearing, until respondent has complied with the terms of this Order.

IT IS FURTHER ORDERED, that file, 02 BAC 046 be, and hereby is, closed.
