The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. **Annie K. Tran** ("Tran"), date of birth 08/05/70, is licensed in the State of Wisconsin as a

Manicurist having license # 85 3250. This license was first granted to her on 01/30/98.

- 2. Tran is listed with the Department of Regulation and Licensing as owner of the Manicuring Establishment Nails Plus Spa, License # 71 1522. The most recent address on file with the Department of Regulation and Licensing for this establishment is 690 Westfield Way Unit D, Pewaukee, WI 53072.
- 3. As owner, Tran was responsible for the daily operations of the establishment and for ensuring that the establishment was in compliance with Wis. Stats. chapter 454 and Admin. Code chapters BC 2, and BC 4.
- 4. On or about October 29, 2002, an inspection of Nails Plus Spa was performed by an investigator from the Department of Regulation and Licensing. During the inspection the investigator found the following:
 - a. Disinfectant found on workstations was cloudy/dirty.
 - b. Poisonous substances were not stored in a locked cabinet or closet.
 - c. Disposable manicuring equipment was not being disposed of properly in used disposable nail files and buffers were being reused.

- d. using a common acrylic powder bowl on multiple clients.
- e. no written protocol describing the procedure for exposure to bodily fluids.

CONCLUSIONS OF LAW

- 1. The Wisconsin Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to sec. 454.15, Wis. Stats.
- 2. The Wisconsin Barbering and Cosmetology Examining Board is authorized to enter into the attached Stipulation pursuant to sec. 227.44(5), Wis. Stats.
 - 3. Respondents **Annie K. Tran and Nails Plus Spa** have violated:
 - a. Wisconsin Statutes section 454.15(2)(i) and Wisconsin Administrative Code sections BC 2.06 and BC 4.10(1)(b) by failing to change disinfectant daily.
 - b. Wisconsin Administrative Code section BC 3.01(6) by not having poisonous substances stored in a locked cabinet or closet.
 - c. Wisconsin Administrative Code section BC 4.02(4) by reusing disposable manicuring
