The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Long Nail Salon, 268 Center Street, Lake Geneva WI 53147 is duly licensed as a manicuring establishment in the state of Wisconsin (license #1306). This license was first granted on October 13, 1998.

- 2. Phan T. Doan, 268 Center Street, Lake Geneva, WI 53147, is listed with the Department of Regulation and Licensing as the owner of Long Nail Salon. As owner, Ms. Doan was and is at all times relevant to this action responsible for compliance with Ch. 454, Stats., and Wisconsin Administrative Code Chs. BC 2, 3 and 4.
- 3. On exact dates unknown, but at least on July 19, 2002, Brenda Dicks was employed at Long Nail Salon to provide manicuring services to the public. At that time, Ms. Dicks did not hold a valid and current Wisconsin manicurist license.
- 4. On exact dates unknown, but at least on July 19, 2002, Long Nail Salon offered aesthetics services to the public. At no time relevant to this action did Long Nail Salon hold a valid and current aesthetics establishment license.
- 5. On July 19, 2002, inspection of Long Nail Salon revealed sanitation violations, including but not limited to: storage of poisonous materials in a public area without locks, failure to maintain the establishment in a sanitary manner, and failure of Phan T. Doan to wash hands between customers.
- 6. In resolution of this matter, Phan T. Doan d/b/a Long Nail Salon consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

- 1. The Wisconsin Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to Sec. 454.15, Stats.
- 2. The Wisconsin Barbering and Cosmetology Examining Board is authorized to enter into the attached stipulation pursuant to Sec. 227.44(5), Stats.
- 3. By the conduct referred to in $\P\P$ 3, 4 and 5 above, Phan T. Doan, d/b/a Long Nail Salon, violated Secs. 454.04(d), and 454.08(1)(b), Stats., and Wis. Admin. Code §§ BC 2.04(1), BC 3.01(6), BC 4.01(1), BC 4.01(2) and BC 4.02(3a).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that

1. Phan T. Doan, d/b/a Long Nail Salon, shall pay to the Department of Regulation and Licensing a forfeiture of TWO THOUSAND THREE HUNDRED dollars (\$2,300.00). Payment shall be submitted in twelve (12) installments. The installments shall be submitted on the following payment schedule:

Ms. Doan may pay the full amount of the forfeiture at any time prior to each monthly due date for payment.

2. Payment shall be made by certified check or money order, payable to the Wisconsin Department of Regulation and Licensing and sent to:

3. In the event Phan T. Doan fails to comply with any of the conditions set forth in $\P\P$ 1 and 2 above, the establishment license of Long Nail Salon (#1306) SHALL BE SUSPENDED, without further notice or hearing, until Ms. Doan has complied with the terms of this Order.

This Order shall become effective upon the date of its signing.
