The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1.	Tara R. S	heehy ("Sheehy	'"), date d	of birth 04/	02/59,	is licensed	in the State	of Wisconsin	as a
Barbering and	Cosmetology	Manager having	license #	# 81 16391	. This li	icense was	first granted	to her on	
05/21/84.									

- 2. **Dale E. Nelson** ("Nelson"), date of birth 06/19/66, is licensed in the State of Wisconsin as a Barbering and Cosmetology Manager having license # 81 26940. This license was first granted to him on 09/29/97.
- 3. **Head Games Salon** ("Salon"), is licensed in the State of Wisconsin as a Barbering and Cosmetology Establishment having license # 80 26391. This license was first granted on 05/12/97.
- 4. At all times relevant to this action, Sheehy and Nelson were responsible for the daily operations of the establishment and for ensuring that the establishment was in compliance with Admin. Code chapter BC 2.
- 5. On or about August 13, 2002, an inspection of the Salon was performed by a Department of Regulation and Licensing investigator. During the inspection, the investigator established that Melanie Bartels was renting a booth from Head Games Salon without a written lease agreement. The investigator further verified that Ms. Bartels did not have an establishment license

CONCLUSIONS OF LAW

- 1. The Wisconsin Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to sec. 454.15, Wis. Stats.
- 2. The Wisconsin Barbering and Cosmetology Examining Board is authorized to enter into the attached Stipulation pursuant to sec. 227.44(5), Wis. Stats.
 - 3. Respondents Tara R. Sheehy, Dale E. Nelson & Head Games Salon

have violated Wisconsin Administrative Code section BC 2.04(1), by assisting Melanie Bartels in unlicensed establishment practice.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED, that the attached Stipulation is hereby accepted.

IT IS FURTHER ORDERED, that Respondent **Head Games Salon** shall pay to the Department of Regulation and Licensing a forfeiture of ONE THOUSAND dollars (\$1,000.00). Payment shall be submitted within sixty (60) days from the date of this order. Payment shall be made by **certified check or money order**, payable to the

Wisconsin Department of Regulation and Licensing and sent to: **Department Monitor, Division of Enforcement, Department of Regulation and Licensing , PO Box 8935, Madison, WI 53708-8935.**

IT IS FURTHER ORDERED, that in the event **Head Games Salon** fails to timely submit payment of the forfeiture as set forth above, the Barbering and Cosmetology Establishment license # 80 26391 SHALL BE SUSPENDED, without further notice or hearing, until respondent has complied with the terms of this Order.

IT IS FURTHER ORDERED, that file, 02 BAC 084 be, and hereby is, closed as to all respondents.
