The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Douglas C. Scheffler, (Date of Birth: August 21, 1965), 720 West 3rd Street, Appleton, WI 54914, is duly licensed as a barbering and cosmetology manager in the state of Wisconsin (license #25677). This license was first granted on May 19, 1994.

- 2. Salon Aura, 259 South Nicolet Road, Appleton WI 54914, is duly licensed as a barbering and cosmetology establishment in the state of Wisconsin (license #26340). This license was first granted on April 10, 1997. Douglas Scheffler is listed with the Department of Regulation and Licensing as the manager of Salon Aura. As manager, Mr. Scheffler was and is at all times relevant to this action responsible for compliance with Ch. 454, Stats., and Wisconsin Administrative Code Chs. BC 2, 3 and 4.
- 3. On exact dates unknown, but at least between December 1, 2000, through December 15, 2000, Darrell Wayne Thomas was employed at Club Aura to provide aesthetics services to the public. At no time relevant to this action did Mr. Thomas hold a valid and current Wisconsin aesthetics license.
- 4. In resolution of this matter, Douglas C. Scheffler consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

- 1. The Wisconsin Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to Sec. 454.15, Stats.
- 2. The Wisconsin Barbering and Cosmetology Examining Board is authorized to enter into the attached stipulation pursuant to Sec. 227.44(5), Stats.
- 3. By the conduct referred to in \P 3, above, Douglas C. Scheffler violated Secs. 454.04(b), Stats., and Wis. Admin. Code \S BC 2.04(1).

ORDER

NOW, THEREFORE, **IT IS HEREBY ORDERED** that

1. Douglas C. Scheffler, shall pay to the Department of Regulation and Licensing a forfeiture of ONE THOUSAND dollars (\$1,000.00). Payment shall be submitted in four (4) installments. The installments shall be submitted according to the following payment schedule:

The full amount of the forfeiture may be paid at any time prior to each due date for payment.

3. In the event Douglas C. Scheffler fails to comply with the conditions set forth in \P 1 and 2 above, the managers license of Mr. Scheffler (#25677) SHALL BE SUSPENDED, without further notice or hearing, until Mr. Scheffler has complied with the terms of this Order.

This Order shall become effective upon the date of its signing.
