The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. **Geralyn S. Sauter** ("Sauter"), date of birth 03/17/58, is licensed in the State of Wisconsin as a Barbering and Cosmetology Manager license # 81 15042. This license was first granted to her on 07/09/80.

2. Sauter is listed with the Department of Regulation and Licensing as Licensee/Responsible Charge of the Barbering and Cosmetology establishment **Trade Secrets # 7733**, License # 80 20640. The most recent address on file with the Department of Regulation and Licensing for this establishment is 5742 Durand Ave., Racine, WI 53406.

3. At all times relevant to this action, Sauter was responsible for the daily operations of the establishment and for ensuring that the establishment was in compliance with Wis. Stats. chapter 454 and Admin. Code chapter BC 2.

4. An inspection of Trade Secrets (#7733) on March 25, 2002, revealed that Sauter, employed one unlicensed practitioner (Angelita Rodriguez), who provided manicuring services to the public without a valid or current Wisconsin manicuring license.

5. In resolution of this matter, Geralyn Sauter, manager, D/B/A Trade Secrets (#7733) consents to the entry of the following Conclusions of Law and Order.

### **CONCLUSIONS OF LAW**

1. The Wisconsin Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to sec. 454.15, Wis. Stats.

2. The Wisconsin Barbering and Cosmetology Examining Board is authorized to enter into the attached Stipulation pursuant to sec. 227.44(5), Wis. Stats.

3. Respondent **Geralyn S. Sauter** has violated Wisconsin Statutes section 454.15(2)(i) and Wisconsin Administrative Code section BC 2.04(1) by authorizing an employee to provide services to clients without a valid or current Wisconsin manicuring license.

### **ORDER**

**NOW, THEREFORE, IT IS HEREBY ORDERED**, that:

1. Geralyn Sauter, shall provide the Department Monitor with the names of any and all duly licensed barber and cosmetologists providing services at the salon. Respondents shall CEASE operation of the business unless and until she has only duly licensed personnel employed to provide barbering and cosmetology services. Respondents shall provide this information to the Department Monitor within 30 days from the date of this Order.

2. Geralyn Sauter, shall pay to the Department of Regulation and Licensing a forfeiture of **one thousand dollars (\$1,000.00)** within 30 days from the date of this Order. Payment shall be made by **certified check or money order**, payable to the Wisconsin Department of Regulation and Licensing and sent to: **Department Monitor, Division of Enforcement, Department of Regulation and Licensing , PO Box 8935, Madison, WI 53708-8935.**

3. In the event Geralyn Sauter fails to timely submit payment of the forfeiture as set forth above, the Barbering and Cosmetology license of Geralyn Sauter SHALL BE SUSPENDED, without further notice or hearing, until respondent has complied with the terms of this Order.

IT IS FURTHER ORDERED, that file, 01 BAC 046 & 01 BAC 47 be, and hereby is, closed as to respondent Geralyn Sauter.
