The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Department. The Department has reviewed this Stipulation and considers it acceptable.

Accordingly, the Department in this matter adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. Reesas Hair Hut, 1600 East Mason, Green Bay, WI 54301, is duly licensed as a barbering and cosmetology establishment in the state of Wisconsin (license #80-26504). This license was first granted on June 24, 1997.
2. Reesas Hair Hut, 1310 Bellevue Street, Green Bay, WI 54302, is duly licensed as a barbering and cosmetology establishment in the state of Wisconsin (license #80-30231). This license was first granted on January 25, 2002. The same Bellevue Street address was licensed as the barbering and cosmetology establishment of Reesas Hair Hut by the state of Wisconsin (license #80-28692) from October 20, 1999, through June 30, 2001, when the license expired and was not renewed. Ms. Pieper has the right to renew this license upon payment of a late fee and the renewal credential fee pursuant to Section 440.08(3), Stats. Ms. Pieper has not as this date submitted any renewal fees and late fees for the expired barbering and cosmetology establishment license.
3. Reesasue L. Pieper, (Date of Birth: March 8, 1963) 3030 Curry Lane, Green Bay, WI 54311, is duly licensed as a barbering and cosmetology manager in the state of Wisconsin (license #81-26806). This license was first granted on June 4, 1997. The Department has learned that Ms. Pieper is presently incarcerated at the Taycheedah Correctional Institution, Post Office Box 1947, 751 County Road K, Fond du Lac, WI 54935-2946.
4. Reesasue L. Pieper is currently listed with the Department of Regulation and Licensing as the owner and manager of all Reesas Hair Hut locations.
5. On or about November 3, 2000, Ms. Pieper was convicted in Brown County Circuit Court of one count of Misdemeanor County/Municipality Worthless Check. A true and correct copy of the Brown County Circuit Court Criminal Complaint and Judgment of Conviction is attached as Exhibit A and is incorporated herein by reference.
6. On or about August 13, 2001, Ms. Pieper was convicted in Brown County Circuit Court of Misdemeanor Class B - Disorderly Conduct. A true and correct copy of the Brown County Circuit Court Criminal Complaint and Judgment of Conviction is attached as Exhibit B and is incorporated herein by reference.
7. On or about November 5, 2001, Ms. Pieper pled No Contest in Brown County Circuit Court to three counts of Felony Manufacture, Distribution or Delivery Cocaine, 5 grams or less, Brown County Case 01CF000544. A true and correct copy of the Brown County Criminal Complaint, Information and Judgment of Conviction is attached as Exhibit C and is incorporated as herein by reference.
8. The Criminal Complaint in Case 01CF000544 indicates that Ms. Pieper had on August 16, 2000, arraigned to sell cocaine to a police confidential informant while working at Reesas Hair Hut, 1310 Bellevue Street, Green Bay, WI. Later that same day, Ms.

Pieper accepted money for the delivery of cocaine at Reesas Hair Hut, 1310 Bellevue Street, Green Bay, WI.

Ms. Pieper then exited the business and delivered the cocaine at her residence.

9. The Criminal Complaint in Case 01CF000544 was filed on June 13, 2001. The Information in Case 01CF000544 was filed on July 17, 2001.

10. In or around the month of October 2001, Ms. Pieper filed with the Department of Regulation and Licensing a Barbering and Cosmetology Establishment Application. A copy of the Barbering and Cosmetology Establishment Application is attached as Exhibit D and is incorporated herein by reference.

11. The application contained the following language on Page 2 of the form:

"a. Has the establishment or any of its officers ever been convicted of a misdemeanor or a felony, or driving while intoxicated (DWI), in this or any other state, **OR** are criminal charges or DWI charge currently pending? **If YES, complete and attach Form #2252.**"

Ms. Pieper checked the box indicated "NO" to the above question.

12. In resolution of this matter, Ms. Pieper and Reesas Hair Hut, consents to the entry of the following Conclusions of Law and Order.

CONCLUSIONS OF LAW

By the conduct referred to in the Finding of Facts above, Respondent Reesasue L. Pieper d/b/a Reesas Hair Hut, violated Secs. 454.15(2)(a), and 454.15(2)(d), Stats.

ORDER

NOW, THEREFORE, **IT IS HEREBY ORDERED** that

1. The Barbering and Cosmetology Board ACCEPTS the SURRENDER of the Barbering and Cosmetology Managers License of Reesasue L. Pieper (license #81-26806) and the SURRENDER of the Barbering and Cosmetology Establishment Licenses of Reesas Hair Huts (license #26504, license #30321 and #28692).

2. IT IS FURTHER ORDERED that should Reesasue L. Pieper in the future apply for any barbering and cosmetology, aesthetics, electrology and manicuring license, the Barbering and Cosmetology Board may in its sole discretion determine, whether, and under what terms and conditions, this permit may be issued.

3. This Order shall become effective upon the date of its signing.
