The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decision of this matter, subject to the approval of the Board. The Board has reviewed this Stipulation and considers it acceptable.

Accordingly, the Board in this matter adopts the attached Stipulation and makes the following:

#### **FINDINGS OF FACT**

1. Brenda S. Dicks, (Date of Birth: June 25, 1957) 131 West Market Street, Number 208, Elkhorn, WI 53121, is duly licensed in the state of Wisconsin as a manicurist (license # 85-5144). The license was first granted on January 30, 2003. The Department has learned that Ms. Dicks's latest address is 10915 County

Highway O, Two Rivers, WI 54241.

- 2. Long Nail Salon, 268 Center Street, Lake Geneva WI 53147 is duly licensed as a manicuring establishment in the state of Wisconsin (license #71-1306). This license was first granted on October 13, 1998.
- 3. On exact dates unknown, but at least on July 19, 2002, Brenda Dicks was employed at Long Nail Salon to provide manicuring services to the public. At that date, Ms. Dicks did not hold a valid and current Wisconsin manicurist license.
- 4. In resolution of this matter, Brenda S. Dicks consents to the entry of the following Conclusions of Law and Order.

#### **CONCLUSIONS OF LAW**

- 1. The Wisconsin Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to Sec. 454.15, Stats.
- 2. The Wisconsin Barbering and Cosmetology Examining Board is authorized to enter into the attached stipulation pursuant to Sec. 227.44(5), Stats.
  - 3. By the conduct referred to in  $\P$  3 above, Brenda S. Dicks violated Sec. 454.04(1)(d), Stats.

#### **ORDER**

NOW, THEREFORE, **IT IS HEREBY ORDERED** that

- 1. Brenda S. Dicks shall pay to the Department of Regulation and Licensing a forfeiture of ONE HUNDRED dollars (\$100.00).
- 2. Payment shall be made by certified check or money order, payable to the Wisconsin Department of Regulation and Licensing and sent to:

3. In the event Brenda S. Dicks fails to comply with the conditions set forth in  $\P\P$  1 and 2 above, the manicurist license of Brenda S. Dicks (#5144) SHALL BE SUSPENDED, without further notice or hearing, until Respondent has complied with the terms of this Order.

This Order shall become effective upon the date of its signing.
