The parties in this matter agree to the terms and conditions of the attached Stipulation as the final decisior of this matter, subject to the approval of the Department. The Department has reviewed this Stipulation and considers it acceptable.

Accordingly, the Department in this matter adopts the attached Stipulation and makes the following:

# **FINDINGS OF FACT**

- 1. Linda C. Mills, (Date of Birth: April 5, 1967) 404 East Avenue, Eagle, WI 53119, is licensed as a barbering and cosmetology manager in the state of Wisconsin (license #81-24738). This license was first granted on March 27, 1992.
- 2. On or about November 6, 2002, Ms. Mills attempted to renew her license with the Department of Regulation and Licensing (hereinafter "Department").
- 3. The license renewal was granted on November 7, 2002. On November 8, 2002, the renewal was denied by the Department under Sec. 440.12, Wis. Stats., which authorizes the Department to deny an application for a credential renewal if the Wisconsin Department of Revenue (hereafter "DOR") certifies that the credential holder is liable for delinquent taxes.
- 4. The license renewal on November 7, 2002, was due to an administrative error by the Department and the error was corrected by the Department on November 8, 2002 resulting in Ms. Mill's license being placed in Non-Working, No-Automatic Renewal status.
- 5. Hair Raisers, S47 W30760 Highway 59, Genesee Depot, WI 53127, is licensed as a barbering and cosmetology establishment in the state of Wisconsin (license #80-17287). The license was first granted on May 2, 1988.
- 6. Linda C. Mills is listed with the Department of Regulation and Licensing as the owner and manager of Hair Raisers.
- 7. On October 25, 2000, the license of Hair Raisers was placed on Non-Working, No Automatic Renewal status with the Department.
- 8. On November 12, 2002, the license was placed on Expired status with the Department and later that same day the license was renewed after Ms. Mills paid the license renewal fees.
  - 9. The Hair Raiser's establishment license then expired on July 1, 2003, and was not renewed.
- 10. On exact dates unknown, but at least on or about October 29, 2002, and October 16, 2003, Linda C. Mills was engaged in the practice of barbering and cosmetology at Hair Raisers, a barbering and cosmetology establishment located at S47 W30760 Highway 59, Genesee Depot, Wisconsin, 53127.
- 11. Ms. Mills has admitted that the establishment remained open and she continued to practice and allow other licensees to practice in her establishment at a time when her manager's license and establishment were in expired and non-renewed status.
  - 12. On October 29, 2003, Ms. Mills reached a repayment agreement with DOR concerning her delinquent

taxes. The Department has received a copy of the Occupational License Clearance Certificate from DOR. A true and correct copy of the *Occupational License Delinquent Tax Release* is attached and incorporated herein as State's Exhibit A.

13. Ms. Mills is eligible to renew her manager's license and establishment license for Hair Raisers and both licenses have been renewed.

In resolution of this matter, Linda C. Mills and Hair Raisers, consents to the entry of the following Conclusions of Law and Order.

# **CONCLUSIONS OF LAW**

- 1. The Wisconsin Barbering and Cosmetology Examining Board has jurisdiction to act in this matter pursuant to Sec. 454.15, Wis. Stats.
- 2. The Wisconsin Barbering and Cosmetology Examining Board is authorized to enter into the attached stipulation pursuant to Sec. 227.44(5), Wis. Stats.
- 3. By the conduct referred to in the above Findings of Fact, Linda C. Mills and Hair Raisers have violated:
  - a. Sec. 454.04(1)(a), Wis. Stats., and Wis. Admin. Code § BC 2.04(1), by engaging in the unlicensed practice of barbering and cosmetology.
  - b. Sec. 454.08(1)(b), Wis. Stats., and Wis. Admin. Code §§ BC 2.04(1) and BC 3.01, by maintaining an unlicensed barbering and cosmetology establishment and allowing others to practice in that unlicensed establishment.
  - c. Sec. 454.08(6), Wis. Stats., and Wis. Admin. Code §§ BC 2.06(5) and BC 3.02(1), by operating a barbering and cosmetology establishment without a licensed manager.

#### ORDER

NOW, THEREFORE, **IT IS HEREBY ORDERED** that:

- 1. Linda C. Mills (lic. # #81-24738) and Hair Raisers (license #80-17287) are hereby **REPRIMANDED** and shall pay, jointly and severally, to the Department of Regulation and Licensing, a forfeiture of **THREE THOUSAND** dollars (\$3,000.00) and partial costs in the amount of **ONE THOUSAND TWO HUNDRED** dollars (\$1,200.00).
- **IT IS FURTHER ORDERED** that the Respondents shall be allowed to repay the forfeiture and partial costs under an installment plan, which may extend over a **two (2) year period**, with each of the **twenty-four (24) payments** in the amount of **\$175.00**, to be submitted on the **15**<sup>th</sup> **day of each month**. The payment schedule shall begin on the 15<sup>th</sup> of the month following the month that this Order shall become effective.

**IT IS FURTHER ORDERED** that the full amount of the forfeiture and partial costs may be pre-paid at any time prior to each due date for payment without a pre-payment penalty.

**IT IS FURTHER ORDERED** that payment shall be made by *certified check or money order*, payable to the Wisconsin Department of Regulation and Licensing and sent to:

**IT IS FURTHER ORDERED** that in the event Linda C. Mills and Hair Raisers fails to comply with the conditions set forth in the paragraphs above, the establishment license of Hair Raisers (#80-17287) and the manager's license of Linda C. Mills, shall be **SUMMARILY SUSPENDED**, without further notice or hearing, until Respondents have complied with the terms of this Order.

This Order shall become effective upon the date of its signing.
