The parties in this matter agree to the terms and conditions of the attached Stipulation as the final disposition of this matter, subject to the approval of the Secretary of the Department of Regulation and Licensing. The Secretary has reviewed this Stipulation and considers it acceptable.

Accordingly, the Department of Regulation and Licensing adopts the attached Stipulation and makes the following:

FINDINGS OF FACT

1. In June 2003, Elite Protection Specialists, LLC entered into a contract with Milwaukee World Festival, Inc. to provide “crowd management/security personnel” to work at Summerfest.
2. Elite Protection Specialists, LLC provided security services for Milwaukee World Festival, Inc. at Summerfest between June 26 and July 6, 2003.
3. On or about July 25, 2003 the Department of Regulation and Licensing received an application for a private detective agency license for Elite Protection Specialists, LLC.
4. In August 2003, Elite Protection Specialists, LLC was paid by Milwaukee World Festival, Inc. for the security services referred to in paragraph 2, above.
5. At no time relevant to these facts did Elite Protection Specialists, LLC hold a valid private detective agency license.

CONCLUSIONS OF LAW

1. The Wisconsin Department of Regulation and Licensing has jurisdiction to act in this matter pursuant to §§440.26(3) and (6), Wis. Stats.
2. The Wisconsin Department of Regulation and Licensing is authorized to enter into the attached Stipulation pursuant to §227.44(5), Wis. Stats.
3. Respondent Elite Protection Specialists, LLC has violated:

§§440.26(a)(1), (3) and (11), Wis. Stats., §§RL 31.01(1)1., 3., and 5, Wis. Adm. Code, and §§RL 35.01(9) and (19), Wis. Adm. Code, by engaging in the business of a private detective agency prior to obtaining a private detective agency license.

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED, that the attached Stipulation is hereby accepted.

IT IS FURTHER ORDERED that the application of Elite Protection Specialists, LLC for a private detective agency license in the State of Wisconsin SHALL BE GRANTED, subject to the following terms and conditions:

1. The private detective agency license for Elite Protection Specialists, LLC is hereby REPRIMANDED.
2. Elite Protection Specialists, LLC shall pay FULL COSTS in this matter in the amount of \$1500.00, within 30 days of the date of this Order. Payment shall be made by certified check or money order, payable to the Wisconsin Department of Regulation and Licensing and sent to: Department Monitor, Division of Enforcement, Department of Regulation and Licensing, PO Box 8935, Madison, WI 53708-8935.
3. In the event that Elite Protection Specialists, LLC fails to pay the \$1500.00 costs within the time and in the manner as set forth above, then and in that event, and without further notice to Elite Protection Specialists, LLC, its private detective agency license shall be suspended without further hearing and without further Order of the Secretary of the Department of Regulation and Licensing, and said suspension shall

continue until the full amount of said costs have been paid to the Department of Regulation and Licensing and its failure to pay the partial costs shall be considered a violation of this Order.

IT IS FURTHER ORDERED, that file #03 UNL 048 be, and hereby is, closed.
