On March 11, 2003, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the petition by Charlene Willis, R.Ph., for a three-month extension of the stay of suspension of her license to practice pharmacy in the State of Wisconsin, as provided within the board's *Final Decision and Order* (*"Order"*) dated October 10, 1995, and a petition that the board modify that the individual/group therapy counseling sessions as required by the *Order*. The request for a reduction in individual/group therapy counseling sessions was not accompanied by supporting documentation by her supervising physician or therapist.

Based upon the foregoing,

IT IS HEREBY ORDERED that Charlene Willis, R.Ph., is granted a three-month stay of the suspension of license #11555 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED that the request that the board modify the individual/group therapy counseling sessions as required by the *Order* is DENIED.
