A meeting of the State of Wisconsin Pharmacy Examining Board was held on April 9, 2003, during which the board reviewed a petition by Robert V. Guzzetta for the granting of a three month stay of suspension as provided by a *Final Decision and Order* ("*Order*") dated September 13, 1994. (94 PHM 77). Also requested was an elimination of the individual/group therapy sessions required by paragraph 2(b)2 of the *Order*.

Based upon the board's review of the petition and the supporting documentation presented;

IT IS HEREBY ORDERED: that Robert V. Guzzetta, is granted a three-month stay of the suspension of license #10594 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED: that the request to eliminate the individual/group therapy sessions individual/group therapy sessions, is GRANTED IN PART; that the individual/group therapy sessions required by paragraph 2(b)2 of the *Order* are reduced to once (1x) per month.
