On December 10, 2003, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the request by John R. Schmitt, R.Ph., for a stay of suspension of his license to practice pharmacy as provided within the board's *Final Decision and Order*, ("*Order*") dated August 13, 1997.

Based upon the board's review of the documentation submitted,

IT IS HEREBY ORDERED: that John R. Schmitt, R.Ph., is denied a three-month stay of the suspension of license #8852 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED: that John R. Schmitt, R.Ph., shall cause to be submitted to the board all urine drug screen test results from July 1, 2003 to the present as a precondition for any further consideration by the board of the granting of a stay of suspension.

IT IS FURTHER ORDERED: that John R. Schmitt, R.Ph., shall cause to be submitted to the board evidence of all professional Wisconsin credentialing currently maintained by his counselor, Kristi H. Kovacs, as a precondition for any further consideration by the board of the granting of a stay of suspension.
