On August 13, 2003, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the request by John R. Schmitt, R.Ph., for a stay of suspension of his license to practice pharmacy as provided within the board's *Final Decision and Order*, ("*Order*") dated August 13, 1997. Schmitt also petitioned to be allowed to work one day per week unsupervised as a pharmacist in charge. Based upon the board's review of the documentation submitted,

IT IS HEREBY ORDERED: that John R. Schmitt, R.Ph., is granted a three-month stay of the suspension of license #8852 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED: that the petition to work unsupervised as a pharmacist in charge is DENIED.

### THE RESPONDENT IS REMINDED THAT THE EMPLOYER REPORTS REQUIRED BY THE ORDER MUST BE PREPARED BY THE RESPONDENT'S ACTUAL WORK SUPERVISOR AT THE PHARMACY WHERE THE RESPONDENT PRACTICES.

THE RESPONDENT IS FURTHER REMINDED THAT PETITIONS FOR STAYS OF SUSPENSION AND ORDER MODIFICATIONS AS WELL AS EMPLOYER, THERAPIST AND DOCTOR REPORTS MUST BE SUBMITTED TIMELY FOR CONSIDERATION BY THE BOARD. LATE SUBMISSION OF PETITIONS, REPORTS AND/OR SUPPORTING DOCUMENTATION MAY RESULT IN DENIAL OF THE REQUESTED BOARD ACTION.
