On May 14, 2003, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the request by John R. Schmitt, R.Ph., for a stay of suspension of his license to practice pharmacy as provided within the board's *Final Decision and Order*, ("*Order*") dated August 13, 1997, and a request for modification of the prohibition against his working as a pharmacist in charge contained in paragraph 2c(3) of the *Order*.

Based upon the board's review of the documentation submitted,

IT IS HEREBY ORDERED: that John R. Schmitt, R.Ph., is granted a three-month stay of the suspension of license #8852 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED: the request for modification of the prohibition against working as a pharmacist in charge contained in paragraph 2c(3) of the *Order* is DENIED. The respondent currently is not authorized for any hours of work as a pharmacist in charge.
