ORDER GRANTING LIMITED LICENSE

By Order of the Wisconsin Dentistry Examining Board, dated May 5, 1993, the dental license of Leon Oliver Cummings, D.D.S., was limited such that he was prohibited from engaging in dental implantology. On January 10, 1997, the Board issued a subsequent *Final Decision and Order* in which Dr. Cummings’ dental license was suspended for an indefinite period, subject to three month stays provided he complied with certain terms and conditions.

On March 5, 2003, the Wisconsin Dentistry Examining Board reviewed the request of Leon Oliver Cummings, D.D.S., for the removal of his suspension and for the return of a limited license. Based upon that request and upon evidence of Dr. Cummings’ compliance with the terms and conditions on his license,

IT IS HEREBY ORDERED that Leon Oliver Cummings, D.D.S., is granted a **LIMITED** license (License #5000027) to practice dentistry in the State of Wisconsin. Dr. Cummings’ license is **limited** in that he shall not engage in any dental implantology.
