Vincent Bergstrom, whose address is 1028 East Juneau Avenue, #728, Milwaukee, WI 53202 (dob, 04/11/50), filed a Request to Apply for Examination for Nursing Home Administrator license with the Board on or about August 23, 2001. On October 25, 2001, the Division of Business Licensure and Regulation, acting on behalf of the Nursing Home Administrator Examining Board, denied the applicant's request to take the examination on the basis that "documentation in the file establishes that you have been convicted of crimes, the circumstances of which substantially relate to the practice of a nursing home administrator".

On June 20, 2002, the Board issued a Final Decision and Order adopting the Stipulation signed by Mr. Bergstrom and a representative of the Division of Enforcement. In the Final Decision and Order, the Board issued a Limited license to Mr. Bergstrom to practice as a nursing home administrator, subject to the limitations and conditions set forth therein. Paragraph 2 of the Order provides that the term of the license shall be for three (3) months, subject to consecutive reinstatement periods of the same duration, for a minimum period of three (3) years. The application for reinstatement of the license for each consecutive three (3) month period shall be conditioned upon the applicant's full compliance with the terms and conditions set forth in the Order. The Board issued a limited license to practice as a nursing home administrator to Mr. Bergstrom on September 19, 2002. On or about December 2, 2002, Mr. Bergstrom submitted a request for reinstatement of his license for a three month period. On December 19, 2002, the Nursing Home Administrator Examining Board granted Mr. Bergstrom's request for reinstatement of his license for a three month period.

### **DECISION**

On or about February 26 , 2003, Mr. Bergstrom submitted a request for reinstatement of his license for a three month period. On May 15, 2003, the Nursing Home Administrator Examining Board considered Mr. Bergstrom's request for reinstatement of his license. The Board voted to grant a limited license to Mr. Bergstrom for a period of three (3) months, subject to full compliance with the limitations, terms and conditions set forth in its Final Decision and Order, dated June 20, 2002.

### **ORDER**

**NOW THEREFORE, IT IS ORDERED** that Vincent Bergstrom be, and hereby is granted, a LIMITED LICENSE to practice as a nursing home administrator in the state of Wisconsin for a period of three (3) months, subject to full compliance with the limitations, terms and conditions set forth in the Board's Final Decision and Order, dated June 20, 2002. [A copy of the Board's Final Decision and Order is attached hereto and incorporated by reference herein.]

### **REQUEST FOR HEARING**

Pursuant to s. RL 1.05 Wis. Adm. Code, applicant may request a hearing within 30 days after the mailing of this Notice. The form of the request shall contain:

- (1) The applicant's name and address;
- (2) The type of license for which the applicant has applied;
- (3) The reasons why the applicant requests a hearing;
- (4) The facts which the applicant intends to prove at the hearing; and,
- (5) A description of the mistake the applicant believes was made, if the applicant claims that the grant of a limited license is based on a mistake in fact or law.
