On February 12, 2003, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the petition by Marilyn L. Kuhrt for a continued three month stay of suspension as provided in the board’s *Final Decision and Order* dated April 1998. (“*Order*”) . Ms. Kuhrt also petitioned for an unlimited license. Ms. Kuhrt appeared before the board.

Based upon a review of the petition and supporting documentation submitted:

IT IS HEREBY ORDERED that Marilyn L. Kuhrt, R.Ph., is GRANTED a two month stay of the suspension of license #9781 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED that the petition for the granting of an unlimited license is denied. Ms. Kuhrt has not practiced pharmacy for a period of 5 years in compliance with the *Order*.
