On July 23, 1998, the Wisconsin Chiropractic Examining Board issued a Final Decision and Order suspending Dr. Helling's license to practice chiropractic for a period of at least two years. Dr. Helling was permitted to petition the board for termination of the suspension under certain terms and conditions. On December 27, 2000, the Board issued an Order Terminating Suspension, Imposing Limitations, and Reinstating License. Under the terms of that order, Dr. Helling was (1) to continue in psychotherapy with Dr. Curtis Levang or another psychotherapist until the treating psychotherapist considered Dr. Helling to have made maximal gains in his insights into personal and professional relationships, and released him, and (2) to attend an additional four hours of continuing education in boundary issues per biennium.

The Board has received satisfactory evidence that Dr. Helling has complied with both of those limitations. Therefore,

All limitations are removed from the license to practice chiropractic issued to Leif C. Helling, D.C., and his license shall henceforth be considered unlimited and unrestricted.
