On April 9, 2003, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the petition by John R. Litzenberg, R.Ph., for a three month extension of the stay of suspension, as provided within the board's *Final Decision and Order* ("*Order*") dated August 12, 1998. Litzenberg also petitioned to remove the limitation contained in the *Order* prohibiting work or employment as a managing pharmacist, (paragraph 2c(2)), and to increase the hours worked as a pharmacist in charge from the current level of 32 hours per week, to 40 hours per week. (paragraph 2c(3))

Based upon the board's review:

IT IS HEREBY ORDERED that John R. Litzenberg, R.Ph., is GRANTED a three month stay of the suspension of license number 10410 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERD that the petition to remove the limitation contained in the *Order* prohibiting work or employment as a managing pharmacist is DENIED.

IT IS FURTHER ORDERD that the petition to increase hours worked as a pharmacist in charge from the current level of 32 hours per week, to 40 hours per week, is GRANTED, provided that all hours worked are at Litzenberg's primary employer, Walgreens.
