On December 10, 2003, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the petition by Ralph G. Koch, R.Ph., for a three-month extension of the stay of suspension, as provided within the board's *Final Decision and Order* ("Order") dated June 16, 1999. Also requested by Mr. Koch and his supervising physician, Charles J. Engel, M.D., was that Koch be returned to full licensure status without limitation. An interim order was entered on January 13, 1999, that provided for an indefinite suspension. The *Order* also provided for an indefinite suspension, effective June 16, 1999.

IT IS HEREBY ORDERED: that Ralph G. Koch, R.Ph., is granted a full unlimited license, #9023, to practice pharmacy in the State of Wisconsin, with all right, title and privilege appurtenant thereto.
