On January 14, 2003, the State of Wisconsin Pharmacy Examining Board reviewed supporting documentation submitted on behalf of a petition by Kevin M. Pampuch for an order granting a stay of suspension pursuant to the *Final Decision and Order* ("Order") in the above-captioned matter entered on March 10, 1999, and a request by his therapist that Pampuch's individual/group therapy sessions be decreased to (1) one time every other week. Pampuch also requested that his urine drug screening be decreased to an unspecified amount.

Based upon the foregoing,

IT IS HEREBY ORDERED, that Kevin Pampuch is granted a three month stay of suspension of license number 12635 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED, the request that Pampuch's individual therapy sessions be decreased to (1) one time every other week is DENIED.

IT IS FURTHER ORDERED, the request that urine drug screening be decreased is DENIED.
