On July 9, 2003, the State of Wisconsin Pharmacy Examining Board reviewed supporting documentation submitted on behalf of a petition by Kevin M. Pampuch for an order granting a stay of suspension pursuant to the *Final Decision and Order* ("*Order*") in the above-captioned matter entered on March 10, 1999, as well as a request by his therapist, Mary Beth Manning, for a reduction in the required individual/group therapy required by paragraph 2.b.(2) of the *Order* from weekly to bi-weekly.
