On September 9, 2003, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the petition by William Karwoski, R.Ph., for a three-month extension of the stay of suspension as provided within the board's *Final Decision and Order* ("Order") dated March 10, 1999, and that the board remove or greatly reduce the individual/group therapy requirements of paragraph 2b.(2) of the *Order*, reduce required urine screens, and increase the hours worked as a pharmacist in charge. (currently 4 hours per week.) Based upon the board's review,

IT IS HEREBY ORDERED that William Karwoski, R.Ph., is granted a three-month stay of the suspension of license #9334 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED that the request to modify the *Order* to reduce the individual/group therapy requirements of paragraph 2b.(2) is granted, as follows: two times (2x) per month consisting of one (1) individual, and one (1) group session.

IT IS FURTHER ORDERED that the request to reduce the monthly required urine screens is granted, to six (6) screens per month.

IT IS FURTHER ORDERED that the request to modify the limitation against acting as a pharmacist in charge contained in paragraph 2c.(3) of the *Order* is granted, with an additional four (4) hours for a total of eight (8). Karwoski may open or close the pharmacy but not consecutively.
