On September 2, 1999, the Wisconsin Chiropractic Examining Board issued a Final Decision and Order suspending Dr. Arnold's license to practice chiropractic for a period of at least two years. Dr. Arnold petitioned the Board for termination of the suspension in December of 2001 and the Board denied the petition at that time. On February 20, 2003, Dr. Arnold again petitioned the Board for termination of the suspension. Dr. Arnold appeared before the Board on March 20, 2003 along with Dr. Charles Lodl and Attorney Mary Michal in support of his petition. Upon review of the Petition for Termination of Suspension and the entire record of this case,

IT IS ORDERED that the suspension imposed in this case on September 2, 1999 is hereby terminated and the license to practice chiropractic issued to Dr. Randal E. Arnold is hereby reinstated, subject to the following limitations:

- 1. Dr. Arnold shall continue to engage in psychotherapy, at Dr. Arnold's expense, with Dr. Charles Lodl or another psychotherapist approved by the board, to address the issues which led to the disciplinary case. Dr. Arnold's treating psychotherapist shall submit in writing to the board every three months a report on Dr. Arnold's participation and progress.
- 2. Dr. Arnold shall observe in his practice the Policies and Procedures attached to the Petition for Termination of Suspension, including the Surveillance Form and the Patient Survey Form.
- 3. Dr. Lodl shall report immediately to the Departmental Monitor any credible information that Dr. Arnold has deviated from the Policies and Procedures. The Board shall have the authority to summarily suspend Dr. Arnold's license upon receipt of information that contains probable cause to believe that Dr. Arnold has deviated from the Policies and Procedures.
