On September 9, 2003, the State of Wisconsin Pharmacy Examining Board reviewed the petition of Andrew P. Rice, R.Ph., for a three-month stay of suspension, as provided within the board's *Final Decision and Order* ("Order") dated September 21, 1999. Mr. Rice also requested to be allowed to act as a pharmacist in charge for an additional 4 hours per week and to be allowed to open and/or close the pharmacy where he is employed. Mr. Rice may currently act as a pharmacist in charge for a total of (8) eight hours per week and may open and/or close the pharmacy but not consecutively.

Based upon the board's review,

IT IS HEREBY ORDERED that Andrew P. Rice, R.Ph., is granted a three month stay of the suspension of license #9594 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED that the request to be allowed to act as a pharmacist in charge for an additional 4 hours per week and to be allowed to consecutively open and/or close the pharmacy where he is employed, is denied.
