On March 11, 2003, the State of Wisconsin Pharmacy Examining Board reviewed the petition of Andrew P. Rice, R.Ph., for a three-month stay of suspension, as provided within the board's *Final Decision and Order* ("*Order"*) dated September 21, 1999. Mr. Rice also requested to be allowed to act as a pharmacist in charge and to be allowed to open and/or close the pharmacy where he is employed. By order dated January 14, 2003, the board ordered in part:

*IT IS FURTHER ORDERED that until further order of the board, Mr. Rice is not to act as a pharmacist in charge or open or close any pharmacy.* 

Based upon the board's review,

IT IS HEREBY ORDERED that Andrew P. Rice, R.Ph., is granted a three month stay of the suspension of license #9594 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED that until further order of the board, Mr. Rice is not to act as a pharmacist in charge or open or close any pharmacy.
