A meeting of the State of Wisconsin Pharmacy Examining Board was held on April 7, 2004, during which the board reviewed a petition by Robert V. Guzzetta for the granting of a three month stay of suspension as provided by a *Final Decision and Order* (“*Order*”) dated September 13, 1994. (94 PHM 77). Also requested by Guzzetta was a reduction in drug screens to 3 per month, and that testing for pemoline be eliminated. Paragraph 2.b.(4)(c) of the *Order* provides that Guzzetta is to submit to drug screening at the frequency of “Four times per month for the third through fifth years following the date of this order.” Although the *Order* was dated September 13, 1994, Guzzetta did not request to begin practice under the *Order* until March 14, 2001, which commenced the five years of required compliance as of that date. Accordingly, Guzzetta is currently required to submit to required drug screens at the frequency of four per month under the terms of the *Order*.

Based upon the board’s review of the petition and the supporting documentation presented;

IT IS HEREBY ORDERED: that Robert V. Guzzetta, is granted a three-month stay of the suspension of license #10594 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED: that the request for a reduction in urine drug screens to three times per month is denied, and the request to eliminate screening for pemoline, is denied.
