Applicant	:	

Brian K. Brown filed a renewal application for a credential to practice as a private security person in Wisconsin. Information received in the application process reflects that the Applicant was convicted of the following crimes:

1. September 11, 2003 – misdemeanor – disorderly conduct

The department and Applicant have entered into a Stipulation by which the department agreed to issue, and Applicant agreed to accept a limited private security persons license subject to specified conditions. Based upon the Stipulation and information of record herein, it is ORDERED as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that Brian K. Brown is GRANTED a PRIVATE SECURITY PERSONS PERMIT subject to the following LIMITATIONS, TERMS AND CONDITIONS:

1. Brian K. Brown shall only perform private security activities under a licensed private detective agency acceptable to the Department. To be acceptable, the employer agrees, in writing, that the terms of this limitation will be complied with and that the employer will cooperate with the applicant in the preparation and submittal to the department of the required reports.

2. Mr. Brown may not transfer to another licensed private detective agency and perform activities under his private security permit without permission, in advance, from the Department of Regulation and Licensing unless the new employer agrees in writing, that the terms of this limitation will be complied with and that the new employer will cooperate with the applicant in the preparation and submittal to the department of the required reports.

3. Brian K. Brown shall file with the department monitor quarterly reports within 5 days before or after the following dates:

December 1, 2004

March 1, 2005

June 1, 2005

September 1, 2005

and every December 1, March 1, June 1 and September 1 until further order of the Department.

4. Each report shall include:

- a. The name, address and telephone number of Mr. Brown and the name, address and telephone number of his employer.

- b. A statement from Mr. Brown confirming his compliance with all the terms of his limited permit and confirming his compliance with the statutes and rules governing the practice of a private security person.

- c. A statement from Mr. Brown's employer evaluating Mr. Brown's performance as a private security person and his compliance with the statutes and rules governing the practice of a private security person.

d. A statement from Mr. Brown accurately stating whether or not he has been convicted of any crime (including Driving While Intoxicated (DWI) or Operating While Intoxicated - OWI) during the term of the Order **OR** if any criminal charges are pending.

5. Mr. Brown shall renew his private security permit in a timely manner, notwithstanding any requirements in this Order.

6. This limitation may not be removed *before November 5, 2005* and only subsequent to a written request to the department on or after that date which also includes a copy of the report as required in this Order.

7. Failure by Mr. Brown to timely comply with the terms of this limitation shall result in the revocation of his limited private security persons permit.

8. Failure by Mr. Brown to timely comply with the terms of the terms and conditions of this Order may result in the summary suspension of Mr. Brown's permit or in the imposition of additional discipline. Upon receipt of verified documentation of a criminal conviction or probation violation subsequent to this Order, the department monitor may issue an order for the revocation of Mr. Brown's limited private security persons permit without further notice or hearing or other proceedings.

DEPARTMENT MONITOR

9. The Department Monitor is the individual designated by the department as its agent to coordinate compliance with the terms of this Order, including receiving reports and coordinating all requests for modification of terms or other petitions. The Department Monitor may be reached as follows:
