On August 18, 2004, the Wisconsin Medical Examining Board reviewed the application for medical licensure submitted by Royal B. Anspach, M.D. Based upon all of the information of record, the Board adopts and issues the following:

### **FINDINGS OF FACT**

- 1. On or about December 1, 2003, Royal B. Anspach, M. D., submitted an application for a license to practice medicine and surgery in Wisconsin, pursuant to the reciprocity of his state board exam.
  - 2. Dr. Anspach's current address is 5433 E. Yolantha, Cave Creek, Arizona, 85331.
- 3. Dr. Anspach is a graduate of the University of Texas Medical Branch in Galveston, Texas. He was awarded a medical degree in 1974 and granted a medical license in the state of Texas in 1974, upon passage of the Texas State Board exams.
- 4. The Texas State Board of Medical Examiners has not taken any disciplinary or non-disciplinary action against Dr. Anspach. In 1995, upon the request of Dr. Anspach, the Texas State Board of Medical Examiners cancelled the physician's license issued to him.
- 5. Dr. Anspach is currently practicing medicine at Tatum Highlands Medical Associates, 26224 N. Tatum Blvd. Suite 5, Phoenix, Arizona. Dr. Anspach has an Arizona medical license (#8995), which was issued to him by reciprocity in 1975. The Arizona State Board of Medical Examiners has not taken any disciplinary or non-disciplinary action against Dr. Anspach.
- 6. Dr. Anspach's medical practice has been primarily in general family practice. Dr. Anspach was board certified in emergency room medicine in 1983 and re-certified in 2002.
- 7. The Texas State Board examinations, which Dr. Anspach passed in 1974, were not substantially equivalent to the Wisconsin because they did not include two topics; pharmacology and psychiatry or a clinical competence examination.
  - 8. Dr. Anspach has not taken the USMLE, SPEX or PLAS examinations.

### **ORDER**

NOW, THERFORE, IT IS ORDERED, that the applicant, Royal B. Anspach, M.D. shall be granted a limited license to practice medicine in the state of Wisconsin. The license granted to Dr. Anspach shall limit his medical practice to the area of general family practice.

IT IS FURTHER ORDERED that this limitation shall be INDEFINITE in duration and shall be subject to modification, upon petition to the Board, if Dr. Anspach passes the USMLE, SPEX and/or PLAS examinations.

The action of the Board in granting this limited license is non-disciplinary.
