On June 10, 2004, pursuant to the Order currently in effect against Todd Coughlin, the Board of Nursing considered the petitioner's request for a three month stay of the suspension. The Department Monitor presented evidence that Mr. Coughlin failed to report his work status to the Board and failed to report all medications he was taking to the Board. In addition, Mr. Coughlin had non-random and non-observed urine screens and abnormal creatin levels suggesting diluted urines. Based upon all information of record herein, the Board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that

1. The extension of the limited license of Todd Coughlin, #29550, to practice as a LPN in Wisconsin is hereby denied.
2. Mr. Coughlin must be in full compliance with the original order for a minimum of six months before petitioning the Board for reinstatement of his limited license.
3. All urine screens must be performed by First Lab.
