On June 13, 2001, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the petition by Eric A. Schuster, R.Ph., for a three month stay of suspension of his license to practice pharmacy as provided within the board's *Final Decision and Order ("Order")* dated May 14, 1996, case number 95 PHM 55. The board was presented with information from the department that the respondent's license to practice pharmacy has not been renewed since 1992.

Based upon the board's review:

IT IS HEREBY ORDERED, that the petition of Eric A. Schuster, R.Ph., for a three month stay of suspension of his license to practice pharmacy is GRANTED SUBJECT TO FIRST MEETING THE FOLLOWING PRE-CONDITIONS:

- 1. The respondent must comply with Wis. Adm. Code § Phar 5.05 and additionally successfully take and pass the MPJE examination required by Wis. Adm. Code § Phar 4.02 (1), and the consultation portion of the laboratory practical examination required by Wis. Adm. Code § Phar 4.02 (4).
- 2. The respondent shall at all times pending satisfaction of the conditions of this order continue to comply with the urine screen requirements of the *Order*.
