On April 22, 2004, pursuant to the Order currently in effect against JEAN K. GOTZMAN, the Board of Nursing considered the report of the Department Monitor which indicated that the Petitioner had a positive drug and alcohol screen and had provided false information to the Board in connection with her request for a three month stay of the suspension. Based upon all information of record herein, the Board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the three month stay of the suspension of the registered nurse license (#80070) of JEAN K. GOTZMAN is hereby REVOKED and the Petitioner's license shall revert to suspended status immediately.

IT IS FURTHER ORDERED that the Petitioner's license shall remain suspended for a period of three (3) months from the effective date of this order and shall remain suspended until the Petitioner submits a request for a stay, with evidence of three months of compliance with the terms of the January 7, 2000, Board order.

This Order is effective upon the date of signing.
