On September 1, 2004, the State of Wisconsin Dentistry Examining Board reviewed the documentation submitted by Dr. Engel stating that Respondent had tested positive for Morphine from a poppy seed bagel. The board decided to have Dr. Markenson appear at the November meeting to discuss his treatment plan and progress.

On November 3, 2004, James Scott Markenson appeared in front of the board to petition for a continuance of his stay of suspension as provided in the Board's Final Decision and Order dated May 3, 2000 and to answer the board's questions.

Based upon the Board's review;

IT IS HEREBY ORDERED that James Scott Markenson, D.D.S., be granted a three-month stay of the suspension of License #3132 to practice dentistry in the State of Wisconsin.

IT IS HEREBY ORDERED that James Scott Markenson, D.D.S., enrolls and begins participation in one of the state approved drug testing companies at his current testing schedule. Respondent shall continue testing with his therapist until the program is fully operable.

Please be advised that the next submission of reports and the petition for an extension of a stay of suspension are due on December 15, 2004.
