On March 4, 2004, pursuant to the Order currently in effect against DIANE BONHAM, the Board of Nursing considered the petitioner's request for a further three month stay of the suspension with modifications. Bonham's petition disclosed that her therapist supported a decrease in her therapy sessions and drug and alcohol screening, based upon her progress in treatment. Based upon all information of record herein, the Board orders as follows:

## **ORDER**

NOW, THEREFORE, IT IS ORDERED that the limited license of DIANE BONHAM, to practice as a registered nurse in Wisconsin is hereby extended for a period of three months.

1. Under the terms of the *Order*, and based upon the petitioner's request, the petitioner's therapy shall be reduced to once per month and the number and frequency of her drug and alcohol screens shall be reduced to fourteen (14) per year.
