On August 18, 2004, the petitioner appeared before the Medical Examining Board to request reinstatement of his stay of the suspension of his medical license (#35645). On July 21, 2004, the Board denied the petitioner's stay, based upon his failure to comply with the terms and conditions of the Board order dated June 22, 2000.

Based upon all information of record herein, including documentation that petitioner has taken immediate actions to address his relapse and safety to return to practice, including enrollment in a partial in-patient hospitalization drug and alcohol treatment program; an increase in his urine screens to six days per week; an increase in his therapy and NA meetings; use of the opiate blocking drug Naltrexone and discontinuation of any opiate medication such as Tramadol; and return to work on a part-time basis and full-time with hours limited to allow fuller participation in treatment and aftercare programs, the Board now finds and enters the following:

### **ORDER**

NOW, THEREFORE, IT IS ORDERED that the request for reinstatement of the stay of suspension of the license of Kenneth E. Sparr, M.D. (lic.#35645) is hereby GRANTED for a period of three months. IT IS FURTHER ORDERED that the petitioner must verify that he remains compliant with the terms and conditions of the original order. This Order is effective upon the date signed below.
