On June 24, 2004, the State of Wisconsin Pharmacy Examining Board reviewed the documentation submitted in support of the petition by Michael J. O'Kray, R.Ph., for a three-month stay of suspension, as provided within the board's *Final Decision and Order*, ("Order") dated July 11, 2000, case number LS 0007112 PHM., and a request that the required drug urine screens be reduced from four to three times per month, and that the individual/group therapy sessions be reduced from two times to once per month. The requests were supported by his therapist.

Based upon the board's review,

IT IS HEREBY ORDERED: that Michael J. O'Kray, R.Ph., is granted a three month stay of the suspension of license #9415 to practice pharmacy in the State of Wisconsin.

IT IS FURTHER ORDERED: that the request that the required drug urine screens be reduced from four times to three times per month is denied.

IT IS FURTHER ORDERED: that the request that the individual/group therapy sessions be reduced from two times to once per month, is denied.
