Pursuant to the Order currently in effect against Fay Imig, RN, Respondent was required among other things to arrange for her employer to provide written reports on a quarterly basis to the Department Monitor for a period of one year from the date of the Order. The Order further provided that

Failure by Respondent to fully and timely comply with the requirements of this Order shall result in the suspension of Respondent's license to practice as a nurse without further notice or hearing, until such time as full compliance with the provisions of this Order has been attained.

On November 7, 2003, the Board of Nursing considered the status of Respondent's compliance with the terms of the Order and concluded that Respondent had failed to provide work reports in accordance with the terms of the Order.

Based upon all information of record herein, the Board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the license of Fay Imig RN, to practice as a registered nurse in the state of Wisconsin is hereby SUSPENDED. Respondent may petition for a termination of this suspension pursuant to the terms of the Order set forth above.

This Order is effective upon the date of signing.
