The Department Monitor presented evidence that Mr. Dziatkiewicz has been non-compliant with his urine screens. Based upon all information of record herein, the Board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the request for a three-month stay of the suspension of the limited license of Lee Allen Dziatkiewicz, #130108, to practice as a RN in Wisconsin is hereby denied. Mr. Dziatkiewicz shall have three months compliance with his original order before another petition for a stay will be considered by the Board.
