On November 17, 2004, the Medical Examining Board considered the petitioner's request for a modification in his weekly therapy requirement, pursuant to the terms and conditions of the Board order dated September 20, 2004, currently in effect. The petitioner's request to modify his therapy until he returns to clinical practice was supported in writing by the petitioner's therapist. Based upon all information of record herein, the Board finds and makes the following:

<u>ORDER</u>

NOW, THEREFORE, IT IS ORDERED that the petitioner's request for modification of the weekly therapy requirements is hereby GRANTED.

IT IS FURTHER ORDERED that the petitioner may receive therapy on the basis of one session per month until he returns to clinical practice. When the petitioner returns to active practice, he must comply with the Board's original order for weekly therapy.
