## ORDER GRANTING STAY, DENIAL OF MODIFICATION LS0109061NUR

On April 22, 2004, the Board of Nursing considered the Petitioner's request for a further three month stay of the suspension of her license practical nurse license. Also, the Petitioner requested a reduction in the number of her required drug and alcohol urine screens. Based upon all information of record herein, the Board orders as follows:

#### **ORDER**

NOW, THEREFORE, IT IS ORDERED that the suspension of the license (#34742) of Jennifer L. Carlson to practice as a licensed practical nurse in Wisconsin is hereby stayed for a further period of three months.

IT IS FURTHER ORDERED that the Petitioner's request for a decrease in the drug and alcohol urine screens is DENIED on the basis that the current level of testing is deemed necessary and appropriate given that the Petitioner has not completed a full year of the Board order testing.
