On April 22, 2004, the Board of Nursing considered the Petitioner's request for a further three month stay of the suspension of her registered nurse license. Based upon all information of record herein, the Board orders as follows:

ORDER

NOW, THEREFORE, IT IS ORDERED that the suspension of the license (# 65082) of Kathleen A. Anglehart to practice as a registered nurse in Wisconsin is hereby stayed for a further period of three months.

1. Under the terms of the *Order* and based upon the Petitioner's good cause shown for modification, the Board removes the restriction on the Petitioner's access to and administration of controlled substances to patients in her care.
