ORDER DENYING THREE MONTH STAY AND MODIFYING ORDER

On May 19, 2004, the Medical Examining Board considered the petitioner's request for a three month stay of the suspension of his medical license, (lic.# 33626), pursuant to the original Board order dated June 13, 2003. Based upon all information of record herein and the report of the Board monitor, the Board finds and enters the following:

#### **ORDER**

NOW, THEREFORE, IT IS ORDERED that the petitioner's request for a three month stay of the suspension is denied in part, for the reason that the Board has concerns about petitioner's mental health status. The petitioner shall obtain a full psychological and neurological evaluation to be submitted by the petitioner's treating health provider to the Board within sixty (60) days from the date of this order.

IT IS FURTHER ORDERED that the petitioner's suspension shall be STAYED for a period of two months and that any further stays shall be reconsidered by the Board upon receipt and review of the petitioner's psychological and neurological evaluations.

This Order is effective upon the date of signing.
