## ORDER RESTORING FULL LICENSURE

On February 19, 2003, the Medical Examining Board (Board) issued its *Final Decision* and Order in the above-captioned matter. By the terms of the Board's Order, Dr. Alrashid's license was suspended for a minimum period of one year. After one year, Dr. Alrashid could apply for reinstatement of full licensure, conditioned upon his compliance with certain limitations on his license. Among these were that Dr. Alrashid complete an assessment establishing his ability to safely practice medicine and surgery.

On February 18, 2004, the Board considered Dr. Alrashid's request for reinstatement of full licensure. Based upon all information of record herein, the Board orders as follows:

### <u>ORDER</u>

NOW, THEREFORE, IT IS HEREBY ORDERED that all limitations on the license of Arkan I. Alrashid to practice medicine and surgery in Wisconsin are terminated, and Dr. Alrashid is reinstated to full licensure, effective immediately.
